WETLANDS ENFORCEMENT OFFICER'S REPORT: Liz Burdick stated there were no applications for wetlands. She has been very busy with zoning issues and did not get an opportunity to look into the path. She still needs to look at site plans for the area. L. Burdick did look at Skyline Drive and talked to the owner. She stated the town and CL&P had cut down many trees on the property. The owner then used woodchips as E & S controls to cover the bare areas. There was a permit issued in 2009 and in 2013 WEO C. Palmer asked the owner to delineate the wetlands which he did. The owner also planted conservation type plantings as well as grass. He has

done everything that was asked of him in 2013. She found no evidence of work in the wetlands or any heavy equipment work. L. Burdick stated the rocks lining the stream edge were collected from the property after the area was cleaned up.
