## 9. EDC BUSINESS & SERVICE DIRECTORY 2021

Commissioner Shelley reported that he has submitted the signed proposal to *The Chronicle*, who has begun selling advertisements for the Directory. He also provided them with all of the respective related materials. The tentative timeline is as follows:

### 10. SENIOR-FRIENDLY / AGE-RESTRICTED HOUSING DISCUSSION

Chairman Chmielewski reported that the development continues to progress; he plans to organize a tour for both the Salem Seniors and Commissioners.

# 11. PLAN OF CONSERVATION AND DEVELOPMENT (POCD)

A copy of the Economic Development section (Chapter 6) of the POCD will be provided to the Commission for review and discussion.

Commissioner Fontneau stated that a survey gauging the residents' attitudes regarding various matters related to the POCD will be made available and its results will be included in the document. He is proposing that the goals tasked to the town's various boards and commissions delineated in the document be prioritized and that the following goals and priorities be included in the economic development section of the document:

- 1. Increase the availability and attractiveness of commercial land
  - a. encourage the Planning & Zoning Commission to identify or rezone optimal parcels that are adjacent to State roads for commercial development (priority: EDC, one to three years)
- 2. Prepare periodic inventories of businesses and services (priorities to be categorized as follows: EDC, one to three years; EDC, three to six years; EDC, six to ten years)

- 3. Encourage the cooperation of businesses, including home occupation businesses
  - a. analyze clusters of home occupations or cottage industries (priority: EDC, one to three years)
  - b. suggest possible synergies between small businesses and cottage industries
- 4. Encourage citizen support for local businesses
  - a. support local businesses recovering from COVID-19 by endorsing or applying for available grants or incentives (priority: EDC/Board of Selectmen)

The Commission's input should be provided to the Planning & Zoning Commission within two months. Chairman Chmielewski recommended that the First Selectman be cc'd on their correspondence for any additional input he might have.

## 12. SALEM BUSINESS OUTREACH AND SUPPORT

### a. Electronic Survey (Commissioner Shelley)

Commissioner Shelley reported that the survey has been placed on hold for the time being. The questions related to the Business & Service Directory were deleted and are being reformulated to center around community outreach and any input the businesses might have regarding the Commission. Chairman Chmielewski requested that the Survey be provided to the Commission and cc'd to the First Selectman for review.

### b. In-Person Outreach (Commissioner Shelley)

Commissioner Shelley reported that the SBA (Small Business Association) is offering a Restaurant Revitalization Fund (RRF) grant to provide restaurants that have been impacted by COVID-19 with funding; information will be forwarded to the Commissioners.

Participants are requested to arrive by 9:30 a.m. The Grand Marshals will be Salem Volunteer Fire Company Chief Chip Weston, Sergeant, U.S. Marine Corps, and Gardner Lake Volunteer Fire Company Deputy Chief Joseph Danao II, Lieutenant Colonel (Ret.), U.S. Army. The parade will be followed by a ceremony featuring Keynote Speaker Department of Veterans Affairs Commissioner Thomas J. Saadi, Lieutenant Colonel, U.S. Army Reserve. He proposed the possibility of engaging the Commissioners to help inform the local businesses regarding the parade and distribute flyers to the local businesses.
