## 3. PUBLIC HEARING:

# Consideration of a resolution to opt out of CT Public Act 17-155, An Act Concerning Temporary Healthcare Structures

Town Planner Rattan recited the Legal Notice as published in *The Day* newspaper on April 10 and 17, 2018. Though not required, notices were sent to the abutting towns as well as the RiverCOG (Lower Connecticut River Valley Council of Governments) and SCCOG (Southeastern CT Council of Governments). Correspondence was received from SCCOG who felt that the decision to opt out of the Public Act would not "result in a negative inter-municipal impact."

Chairman Duncan stated that the Commission has discussed the Statute on several occasions and asked if there were any members from the public who would like to speak. There being none, he asked if any of the Commissioners would like to speak. Vice-Chairman Smith stated that, based upon their discussions, it was clear that the Commission agreed that the Statute does not provide any benefit to the Town and, as such, has voted in favor of opting out of the Public Act.

Vice-Chairman Smith recited and the Commissioners reviewed the proposed Resolution, making the following amendments:

At their regular meeting of *April 24, 2018* following a public hearing the Salem Planning & Zoning Commission rendered the following decisions:

**ZRA 4-18-01**. Town of Salem Planning & Zoning Commission. Application to: Opt out of CT Public Act 17-155, An Act Concerning Temporary Healthcare Structures (THCS). Application to Opt Out was *APPROVED*.

### RESOLUTION

**WHEREAS**, Public Act 17-155 allows municipalities to "opt out" of the requirements of that Act; and

**WHEREAS**, the Planning and Zoning Commission voted to "opt out" on *April 24, 2018* indicating that it believes that it is appropriate for Connecticut municipalities to provide housing options for caregivers for persons requiring such assistance due to age, disability, or illness, however;

WHEREAS, the Act itself contains inconsistencies, such as the notice requirements (certified mail) which conflict with Connecticut General Statutes Section 8-7d(a), and the Act fails to specify the procedure by which approvals are to be granted, thereby creating ambiguities and potential appeals; and

WHEREAS the Town of Salem lacks sufficient volunteers or staff, to comply with many of the procedural requirements of the Act; and

WHEREAS the Town of Salem allows accessory apartments as of right in residential zones; and

WHEREAS the processing time for a zoning permit for an accessory apartment is minimal; and

WHEREAS Accessory Apartments better serve the housing needs of Salem residents by offering permanent units; and

**WHEREAS**, the Town of Salem relies upon septic systems a THCS would require an exception from Connecticut Department of Health in addition to Uncas Health District approval impairing the ability of the town to ensure the mandated approval timeline; and

**WHEREAS** bonding levels commensurate with the cost of removal of THCS units would be cost prohibitive to constituents,

**WHEREAS**, the Planning and Zoning Commission has advised the Town Council Board of Selectmen that the existing regulations pertaining to accessory apartments eliminate the need for this additional provision and the provision of Public Act 17-155 would result in procedural issues;

**NOW, THEREFORE, BE IT RESOLVED**, that, in accordance with the recommendation of the Planning and Zoning Commission, the Town Council does hereby affirmatively opt out of the provisions of Public Act 17-155;

Chairman Duncan asked if there was anyone who would like to speak regarding the Resolution. There being none, the Public Hearing was closed.
